Whereas the Developer recorded the Declaration of Covenants, Conditions and Restrictions of Chancellors Row in Official Records Book 3504, Page 933, and the Bylaws of Chancellors Row recorded in Official Records Book Doc#20160363816, and all written amendments or modifications recorded thereafter in the Public Records of Orange County, Florida [hereinafter referred to as the "Declaration"]; and,

Whereas Article V provides the Architectural Control Committee by and through the Board of Directors to adopt standards including those regarding fencing;

Now therefore, in consideration of the premises and other good and valuable consideration given, the Board of Directors and Architectural Review Committee of Chancellors Row Homeowners Association, Inc., hereby adopt the following guidelines with respect to permissible fences within Chancellors Row:

Material:

- White or Beige Vinyl.
- Black Rod Iron Ornamental
- Previously wood fences were allowed those that exist as of the date of this
 Resolution are hereby grandfathered in. Upon such time that they need to be
 replaced, Owners shall be required to select the material provided herein.

Height:

- Six feet at the highest point.
- Four feet for vinyl picket.

• Posts 18" below Earth with cement support.

Gates:

 Gates shall be located such that they open only onto an Owner's Lot and not to an adjoining Lot or Common Area.
